

## About VFS Global, the Sole Authorized Service Provider

Embassy of India, Madrid has authorized **VFS Global**, with effect from 07 April, 2017, to provide Outsourced Services pertaining to Visas, Passports, OCI Cards, Conversion of PIO to OCI Cards and the following Consular Services: Attestation of Documents, Renunciation of Indian Passport/Surrender of Indian passport/Deemed Surrender of Indian Passport, Police Clearance Certificate.

Service provider is authorized to collect Government of India fees from applicants and make a preliminary examination of the applications to see that they are in order, accompanied by requisite supporting documents, and to guide the applicants wherever deficiencies are noticed. Please note that service provider is not authorized to decide whether Visa, Passport, OCI card would be granted or refused to any applicant; this decision is taken by the Embassy of India, Madrid.

**Service fee:** In lieu of the above services, VFS Global is authorized to charge the following service fee only:

- (a) Basic Service Fee: €17.97 (Euros Seventeen and Cents Ninety Seven only)
- (b) Basic Service Fee + ten fingerprint biometrics: €17.97 (Euros Seventeen and Cents Ninety Seven only)
- (c) Basic Service Fee + ten fingerprint biometrics+ facial biometrics: €17.97 (Euros Seventeen and Cents Ninety Seven only)
- (d) Bank Commission/Agency charges (on actual basis)
- (e) Other Value Added Services (VAS) approved by the Embassy of India as mentioned in the chart below. These VAS are purely optional and are **NOT** mandatory for applicants. They may choose to avail them if they feel the need to.

The above charges are *inclusive of all taxes etc.*

The service provider is obliged to provide a bar-coded receipt to each applicant giving details of the amount collected by them.
